The debits will be transferred to your account in full. Please take utmost care to meet the standards while supplying the goods to avoid any claims.
- All goods should be AZO Free and NICKEL FREE irrespective of the process. Raw Materials and Accessories will have to be approved as per standards accepted.
- Fabrics and Accessories supplied if found defective after any process / even after shipment will attract full claims as charged by our buyers.
- Any delay/rescheduling will have to be approved in writing after giving valid reasons in writing to our company. Any delay unapproved will attract full value of Airfreight and discount that may be arise/claimed by the buyers.
- You will not be supplying the branded items to any one. Any such acts may attract claims.
- Kindly provide insurance coverage for the goods while in transit & during process.
- Please obtain approval in writing before commencing bulk production.
- Please obtain approval in writing before commencing bulk production.
